# AREA PROFILES

This project was previously called the Regional and Rural Edition (RRE) to emphasize its focus on regional and rural recreation needs and priorities. This project name was used during the data collection, and community engagement and outreach phases which occurred primarily in 2021. As this report was being completed in 2022, DPR decided to rename the project the Parks Needs Assessment Plus (PNA+) to clarify and better communicate that this project complements and offers new information not previously included in the 2016 Parks Needs Assessment (PNA), such as mapping and analyses related to population vulnerability, environmental benefits, environmental burdens, and priority areas for environmental conservation, environmental restoration, regional recreation, and rural recreation. (Please note that there remains some text and graphic references to the RRE in this document because that was the project name when some components of this study were completed.)

## STUDY AREA DESCRIPTION

### PHYSICAL CONTEXT

The Unincorporated Lancaster/Unincorporated Palmdale/Quartz Hill Study Area is located in the Antelope Valley Regional Study Area. The Unincorporated Lancaster/Unincorporated Palmdale/Quartz Hill Study Area is located between the cities of Palmdale and Lancaster in southern Antelope Valley. The Study Area encompasses approximately 14 square miles. The Study Area is broken up into four non-contiguous areas of Antelope Valley located within the cities of Palmdale and Lancaster. The unincorporated community of Quartz Hill and unincorporated neighborhoods of Palmdale and Lancaster are located in this Study Area.

### STUDY AREA CONSIDERATIONS

The Study Area has constraints, including natural hazards, such as earthquakes and extreme heat, somewhat limited public transportation infrastructure, and limited water supply. The desirability of rural living and the availability of affordable housing have led to significant growth in the many unincorporated communities, though Quartz Hill has seen a small decrease in population since 2010. Some parts of the Study Area, including Quartz Hill, are generally better served by public transportation, pedestrian infrastructure, schools, and recreational facilities than others, such as unincorporated Lancaster.



### KEY ANALYSIS TAKEAWAYS

- » Environmental vulnerability and transportation barriers are the most prevalent dimensions of population vulnerability in the Study Area.
  - » Only 28% of residents live within walking distance of a rural recreation site.
  - » No rural recreation sites in the Study Area are served by public transit.
- » The majority of rural recreation site area in the Study Area falls under Local Parks. The Study Area contains no Nature-Based Recreation Area land or Regional Recreational Park area.
- » A very small proportion of Study Area residents live within a 5-mile drive of overnight accommodations (0%), trails and pathways (0.3%), and experiential learning opportunities (0.3%).
- » High level of population vulnerability is the most pronounced aspect of rural recreation priority in the Study Area.

### KEY COMMUNITY ENGAGEMENT TAKEAWAYS

- » Heat, lack of shade, safety, time, distance, costs of travelling and lack of information about facilities are identified barriers to park use for residents who live in the Study Area.
- » Residents say they need more recreation and swimming facilities, expanded facilities hours, safe places to ride bikes, more trails and greenspaces, and places for exercising animals.
- » Greatest needs are for places to swim; play or attend fitness classes; gather with friends and family; and be surrounded by nature.
- » 37% of survey respondents from the study area say they are recreating outside less often due to COVID, and 86% are looking for more recreation activities closer to home because of the pandemic.




## Overnight Accommodations



# COMMUNITY ENGAGEMENT THEMES

## BARRIERS RESIDENTS EXPERIENCE TO USING PARKS AND FACILITIES



### HEAT

Heat, especially in summer, limits what people can do outside.



### LACK OF SHADE

Without shade, many parks are unusable during hot months.



### LIMITED ACCESS TO WATER

There is a lack of water facilities and features like fountains, swimming pools and splash pads to keep residents cool and hydrated in hot months.



### SAFETY CONCERNS

Residents don't feel safe at parks. Better trail connectivity and safer riding opportunities along busy streets and in parks are needed.



### TIME

Many residents do not have time, due to work or other reasons, to travel to and/or use regional parks and facilities.



### DISTANCE

Many residents and families have to travel long distances to parks and facilities.



### COST

Affording the costs of travel to parks, including gas, limit what activities residents can do.



### LIMITED ADA ACCESSIBILITY

Facilities and programming are not accessible to disabled and older residents, and many people find it difficult to get outside due to health issues.



### NOT ENOUGH MAINTENANCE AT PARKS AND FACILITIES

Park facilities and trails need repairs, maintenance and restoration.



### LACK OF RECREATION FACILITIES

Nearby parks lack outdoor recreation areas, sports fields, swimming facilities, skate parks, gathering and open spaces, and places to ride horses and exercise animals.



### LIMITED HOURS

Facilities are not open when people can use them.

**"The weather - usually too hot and/or too windy."**

**"No safe place to ride bikes with kids near me."**

**"There is no shade at the newer parks."**

**"Gas money to drive stops me from doing more things with my grandkids."**

**"Lack of parking for horse trailers; lack of safe designated trails."**

# COMMUNITY ENGAGEMENT THEMES

## COMMUNITY SUGGESTIONS TO INCREASE AND IMPROVE VISITS TO RURAL PARKS AND FACILITIES



### MORE SHADE

Shaded seating, play areas and walking trails, and more trees between and around parks.



### ACCESS TO WATER

Additional water facilities and features like swimming pools and access to waterways for activities like fishing.



### ADA ACCESSIBILITY

Provide wheelchair and disabled accessible trails and facilities, including restrooms.



### IMPROVED MAINTENANCE AND INFRASTRUCTURE

Clean and maintain restrooms and trails and provide more wildfire mitigation and removal of dead vegetation.



### MORE CULTURAL EVENTS AND ACTIVITIES

Open up park spaces for the community to hold more events and provide more cultural activities and performances.



### MORE RECREATION FACILITIES

Extend facilities hours, provide more tennis and racquetball courts, spaces for swimming and indoor sports, skate parks, walking and jogging tracks, and gathering spaces.



### MORE FACILITIES FOR EQUESTRIAN USE

Parking for horse trailers at equestrian staging areas and trailheads, and places to hold equestrian events.



### MORE TRAILS FOR EQUESTRIAN AND PEDESTRIAN USE

Additional trails for horse riding, and walking trails.



### DEDICATED USE TRAILS

Provide separate trails for hiking, biking, equestrian use to help mitigate conflict and increase safety for all users along trails.



### ENHANCE CONNECTIVITY

Provide greenways and trail networks that connect communities, parks and trails, and provide safe transportation corridors for bicyclists, equestrians and pedestrians.



### EXPAND GREEN SPACE

More trees, native habitat gardens, and natural open space.

"A place to ride bikes with kids."

"We need a swimming area locally."

"More cultural activities [like] movies and music."

"Add to the skate park."

"Better swimming hours for seniors."

"Hiking and horseback riding trails."





Areas With Access to the Fewest Recreation Opportunity Types







