

APPENDIX B RURAL STUDY AREA PROFILES

This project was previously called the Regional and Rural Edition (RRE) to emphasize its focus on regional and rural recreation needs and priorities. This project name was used during the data collection, and community engagement and outreach phases which occurred primarily in 2021. As this report was being completed in 2022, DPR decided to rename the project the Parks Needs Assessment Plus (PNA+) to clarify and better communicate that this project complements and offers new information not previously included in the 2016 Parks Needs Assessment (PNA), such as mapping and analyses related to population vulnerability, environmental benefits, environmental burdens, and priority areas for environmental conservation, environmental restoration, regional recreation, and rural recreation. (Please note that there remains some text and graphic references to the RRE in this document because that was the project name when some components of this study were completed.)

STUDY AREA DESCRIPTION

PHYSICAL CONTEXT

The Acton/South Antelope Valley Study Area is bordered by the City of Palmdale and southern Antelope Valley to the north, the San Gabriel Mountains and Antelope Valley to the east, the San Gabriel Mountains to the south, and the Sierra Pelona Mountains to the west. The Study Area encompasses approximately 180 square miles.

STUDY AREA CONSIDERATIONS

The Study Area has major constraints, including natural hazards, such as earthquakes and wildfire, and limited infrastructure, including public transit service. The desirability of rural living and the availability of affordable housing have led to significant growth in the many unincorporated communities, though Acton has seen a small decline in population since 2010. The Study Area supports many opportunities for outdoor recreation in the Angeles National Forest; however, outdoor recreation in rugged natural areas is not always accessible to the general public, which may be intimidated by rugged areas or lack knowledge of how to navigate and enjoy these areas. In comparison, the Study Area has less general recreation facilities, including local parks, aquatic facilities, and sports facilities. Many Study Area residents commute long distances to Santa Clarita, Palmdale, Lancaster, and the Los Angeles Basin to access employment and specialized recreation opportunities.

KEY ANALYSIS TAKEAWAYS

- » Transportation barriers are the most prevalent dimension of population vulnerability in the Study Area.
 - Only 7% of residents live within walking distance of a rural recreation site.
 - » No rural recreation sites in the Study Area are served by public transit.
- » The majority of rural recreation site area in the Study Area falls under Nature-Based Recreation Area. The Study Area contains very few acres of Local Parks and Regional Recreational Parks relative to overall rural recreation site area.
- » Only a small proportion of Study Area residents (13.5%) live within a 5-mile drive of waterbased recreation opportunities such as swimming pools and splash pads.
- Residents of this Study Area have access to a limited range of rural recreation opportunity types.


KEY COMMUNITY ENGAGEMENT TAKEAWAYS

- » Heat, distance, and safety are identified barriers to park use for residents who live in the Study Area.
- » Residents say they need more recreation facilities and green spaces, and that these facilities need to be affordable.
- » Greatest needs are for places to picnic or gather with friends and family; swim; be surrounded by nature; play; heated/cooled place to gather; drop in and play sports; hold cultural activities; and to enjoy lawn and trees.
- Almost half of respondents are recreating outside more and almost 90% are looking to do that closer to home because of COVID.

In Fall 2021, the Friends of Acton Park conducted a survey to update community priorities for recreation from those identified in the 2016 PNA. Feedback was provided by paper survey, email, text, and through the Friends' Facebook page; respondents were asked to rank their top five elements. From the amenities listed, the most votes were cast for a swimming pool, which was the clear priority. Other amenities receiving strong support include tennis court, skateboard park, splash pad, shade trees and general shade, dog park, and extended walking paths. A variety of other amenities received support but to a lesser degree along with a few write in options.



























COMMUNITY ENGAGEMENT THEMES

BARRIERS RESIDENTS EXPERIENCE TO USING PARKS AND FACILITIES



SAFETY CONCERNS

Residents don't feel safe at parks.

Better trail connectivity and safer riding opportunities along busy streets are needed.



HEAT

Heat, especially in summer, limits what people can do outside.



LIMITED ACCESS TO WATER

There is a lack of water facilities and features like water fountains, swimming pools and splash pads to keep residents cool and hydrated in hot months. Desert trails are dry and lack greenery.



LACK OF FACILITIES AND PROGRAMMING

Nearby parks lack tennis courts and swimming pools, and provide few activities for residents to participate in.



DISTANCE

Many residents and families have to travel long distances to parks and facilities.



LIMITED HOURS

Facilities are not open when people can use them.

"The hours at parks with water are limited and closes when I am coming home from work."

"Trails are not connected.

It's too hard and dangerous to ride by busy streets."

"Gym membership is too expensive and indoor gyms seem unsafe at the moment."

MORE CULTURAL EVENTS AND ACTIVITIES

More community events and cultural activities.

Shaded seating, play areas and walking trails, and more trees between and around parks.

"Available public gym equipment for exercising, with sun protection to prevent the equipment from heating up."


"I would like to see some of the open spaces in the desert surrounded by big green pines, grand firs, spruce trees with a walking trail, lake and a play area for kids."

High Levels of Social and Transportation Barriers



Areas With Access to the Fewest Recreation Opportunity Types










