This project was previously called the Regional and Rural Edition (RRE) to emphasize its focus on regional and rural recreation needs and priorities. This project name was used during the data collection, and community engagement and outreach phases which occurred primarily in 2021. As this report was being completed in 2022, DPR decided to rename the project the Parks Needs Assessment Plus (PNA+) to clarify and better communicate that this project complements and offers new information not previously included in the 2016 Parks Needs Assessment (PNA), such as mapping and analyses related to population vulnerability, environmental benefits, environmental burdens, and priority areas for environmental conservation, environmental restoration, regional recreation, and rural recreation. (Please note that there remains some text and graphic references to the RRE in this document because that was the project name when some components of this study were completed.)

STUDY AREA DESCRIPTION

PHYSICAL CONTEXT

The Stevenson Ranch/Newhall Ranch Study Area is located in the Santa Clarita Valley Regional Study Area. The Study Area is bordered by the Santa Clara River to the north, Interstate 5 to the east, Santa Clarita Woodlands Park and open space to the south, and borders the western boundary of Los Angeles County to the west. The Study Area encompasses approximately 50 square miles. The unincorporated communities of Stevenson Ranch and Newhall Ranch are located in the Study Area.

STUDY AREA CONSIDERATIONS

The Study Area has several considerations, including natural hazards like wildfire and earthquakes and limited public transit service. The study area is not well connected, as the communities are high income, exurban and it is likely residents commute far distances. The desirability of rural living and the availability of affordable housing have led to population growth in the Study Area, including the proposed master planned community of Newhall Ranch, which proposes over 22,000 dwelling units on 4,835 acres. The development would include parks and schools, acreages of commercial, business park and light manufacturing, warehousing and distribution land uses, open spaces, roadways and community facilities (library and fire stations) and a new 6.9 million gallon per day water reclamation plant.


KEY ANALYSIS TAKEAWAYS

- » Transportation barriers is the most prevalent dimension of population vulnerability in the Study Area.
 - » No rural recreation sites in the Study Area are served by public transit.
- The majority of rural recreation site area in the Study Area falls under Nature-Based Recreation Area.
- » The lowest percentage of Study Area residents do not live within a 5-mile drive of overnight accommodations (43.3%).
- » Low proximity to rural recreation sites and access to few recreation opportunity types are the most pronounced aspects of rural recreation priority in the Study Area.

KEY COMMUNITY ENGAGEMENT TAKEAWAYS

- » Distance, time, limited information and lack of nearby facilities and amenities are identified barriers to park use for residents who live in the Study Area.
- » Residents say they need more recreation facilities and green spaces nearby, safe access for pedestrians, and more information about available amenities.
- Screatest needs are for places to play and bring animals to exercise; gather with friends and family; and to be surrounded by nature.



COMPOSITE POPULATION VULNERABILITY











































High Levels of Social and Transportation Barriers




Proximity to Fewest Recreation Opportunity Types


